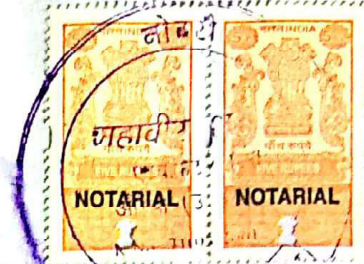


AFFIDAVIT
